## What is the Massachusetts Department of Public Utilities (DPU)?



The Massachusetts Department of Public Utilities (DPU) is a state agency responsible for regulating various utility services within Massachusetts. Its primary role is to oversee and ensure the safe, reliable, and affordable provision of essential utility services.

- Proposed and mandated system improvements of \$4.1M
   Infrastructure Improvements
- The funding of those improvements will result in annual interest payments of approximately \$300,000
- Of the projected expense increase of \$182,000, the cost of additional personnel is \$145,000
- Additional payroll tax related to added employees
- Additional property tax related to increase in plant investments
- Additional depreciation expense related to plant investment

#### **Improvements**



- Storage Tank
- "Greensand" manganese removal system
  - Greensand filtration is an effective method for removing both iron and manganese from water sources.
  - Cost-effective compared to other treatment methods.
  - The system is relatively low-maintenance, requiring periodic backwashing and occasional regeneration.
- Maintenance Building
  - Chemical storage
  - Monitoring and equipment

Re: Division Street Hydrant

Dear Mr. Pruhenski,

Thank you for your August  $1^{\rm st}$  letter regarding the hydrant on Division Street that the Great Barrington Fire Department used on July  $27^{\rm th}$ . The Housatonic Water Works Company (HWC) is committed to the maintenance of a sound water infrastructure for our community.

We inspected the hydrant this date and did not observe any malfunction of the hydrant itself. However, it is a "service hydrant" which is used for system maintenance such as flushing. It is not intended for fireflighting. The hydrant, located nearby on North Plain Road at the intersection with Division Street, provides fire flow.

Additional service hydrants are located on Prospect and High Streets. We also have blow-offs throughout town. Great Barrington is not charged for service hydrants or blow-offs.

We are in the process of identifying pressures and flow rates for hydrants throughout the system and plan to install ring labels on them to identify use and flow range so that an incident like this does not occur again.

Chief Jennings was familiar with the service hydrants and hydrant flows throughout our system. We would be glad to meet with Interim Chief Mead and the incoming chief to share our "institutional knowledge" and address any questions or concerns going forward.

Our long-term plans to improve water pressures and hydrant flows in the core village area include the installation of an elevated storage tank on High Street and distribution main upgrades based upon the 2022 hydraulic study. A copy of the report is attached.

I hope this information clarifies the situation encountered July 27th at the hydrant on Division Street.
